SECURITY GUARD SERVICE AGREEMENT

TERMS & CONDITIONS:

This agreement entered into as of this 01 day of January 2023 by and between **BLACK HAWK PROTECTION SERVICES INC.** a Corporation formed under the laws of the State of Florida, U.S.A. having its principal office at 7320 NW 56 Street, Miami, Florida 33166, and **CLIENT**, identify as "SONOMA AT DORAL H.O.A." as described on the **SPECIFICATIONS SCHEDULE**.

WHEREAS BLACK HAWK PROTECTION SERVICES INC. is engaged in the business of providing various types and classifications of Security Guard Services:

And WHEREAS, CLIENT desires to hire BLACK HAWK PROTECTION SERVICES INC. to provide Security Guard Services, as hereinafter described and upon the terms and conditions set forth herein;

NOW, THEREFORE, in consideration of the promises herein contained and other valuables consideration, receipt of which hereby acknowledged, the parties hereby agree to terms and conditions set forth herein, which **CLIENT** has read and accepted.

1.- SECURITY GUARD SERVICES:

- a. During the term of this agreement, CLIENT hereby hires and agrees to use, on an exclusive basis, and BLACK HAWK PROTECTION SERVICES INC. hereby agrees to provide CLIENT, the Security Guard Services described on the SPECIFICATIONS SCHEDULE to this agreement.
- b. The number of guards, guard post, their location, and the hours and nature of the guard duties may be varied from time to time at the CLIENT'S request to meet the CLIENT'S requirements: provided however, that any variations or amendments from the SPECIFICATIONS SCHEDULE shall be in writing and signed by both parties in order to be effective.
- c. The guards shall perform such guard services as the CLIENT may request in writing from time to time, so long as approved by BLACK HAWK PROTECTION SERVICES INC. in writing. All guards shall be and remain employees of BLACK HAWK PROTECTION SERVICES INC., which is an independent contractor of CLIENT. The payment of wages, federal and state taxes, social security, and unemployment compensation taxes shall be the sole function and responsibility of BLACK HAWK PROTECTION SERVICES INC.

- d. CLIENT acknowledges that the degree and amount of security services provided by BLACK HAWK PROTECTION SERVICES INC. are based upon the desires and directions provided by CLIENT; and that additional services are available at additional cost. CLIENT acknowledge that the furnishing of security services provided for herein BLACK HAWK PROTECTION SERVICES INC. does not guarantee protection against all contingencies. BLACK HAWK PROTECTION SERVICES INC. shall have not obligation to suggest or recommend additional services to CLIENT; and any suggestion or recommendations made by BLACK HAWK PROTECTION SERVICES INC. shall not constitute or be deemed an acknowledge that the level or type of services being provided under this agreement are not sufficient or adequate for the task required.
- e. BLACK HAWK PROTECTION SERVICES INC. agrees that the security services covered by this Agreement shall be performed in accord with accepted security practices and standards. BLACK HAWK PROTECTION SERVICES INC. further agrees that upon request by the CLIENT, it will reassign any of its employees who in the opinion of the CLIENT are not satisfactory.
- f. Security guards personnel shall perform all duties in accordance with written instructions as agreed upon between the CLIENT and BLACK HAWK PROTECTION SERVICES INC. which shall be set forth in SPECIFICATIONS SCHEDULE, attached hereto and made a part of this Agreement.
- g. In the event BLACK HAWK PROTECTION SERVICES INC. provide service to any additional location of CLIENT after the date of this agreement, whether or not specifically enumerated on the SPECIFICATIONS SCHEDULE, CLIENT shall be bound by all of the terms and conditions, including rates, set forth herein.

2.- TERMS:

- a. Services furnished by **BLACK HAWK PROTECTION SERVICES INC.** shall commence on the **COMMENCEMENT DATE** stated on the **SPECIFICATIONS SCHEDULE**, and shall continue indefinitely unless this agreement expire or is terminated in accordance of with the terms hereof.
- b. This agreement is for a specific term., that is, with a fixed COMMENCEMENT DATE and EXPIRATION DATE stated on the **SPECIFICATION SCHEDULE**:
 - (i) This agreement may be canceled by either party for cause, which shall require thirty (30) days written notice pursuant to paragraph 7, which notice shall specify the cause alleged. CLIENT shall have not right to terminate this agreement without cause.
 - (ii) This agreement shall renew for success like terms, subject to all terms and provisions of this agreement, unless **CLIENT** shall give no less than thirty (30) days notice under paragraph 7 of its intention that this agreement is renewed.

- (iii) In the event CLIENT terminates without the required notice, or breaches this agreement resulting in cancellation by BLACK HAWK PROTECTION SERVICES INC., CLIENT shall be liable for damages, but in no event less than the amount invoiced by BLACK HAWK PROTECTION SERVICES INC. to CLIENT the preceding thirty (30) days of the agreement, which sum shall constitute liquidated damages.
- c. In the event that CLIENT based on the service provided is not satisfied and determines that "cause" exits for the termination of this Agreement, CLIENT shall give written notice to BLACK HAWK PROTECTION SERVICES INC. in the manner specified in paragraph 7 below, stating with particularity the alleged "cause". BLACK HAWK PROTECTION SERVICES INC. shall then have a period of thirty (30) days from the receipt of such notice to cure the CLIENT'S reasonable satisfaction; failing which CLIENT may elect to terminate this agreement. If the alleged "cause" is solved in the above stated period, CLIENT shall have not right to terminate this agreement.
- d. The failure of **CLIENT** to pay any invoice when due shall constitute an event of default entitling **BLACK HAWK PROTECTION SERVICES INC.** to terminate this agreement, without necessity of thirty (30) days written notice, in addition to all other rights and remedies.

3.- **RATES**:

- a. CLIENT shall pay BLACK HAWK PROTECTION SERVICES INC. the base rate set forth on the SPECIFICATION SCHEDULE for the service enumerated therein.
- b. Holidays Rates will be billed on the following holidays: Memorial Day, 4th of July, Labor Day, Thanksgiving, Christmas and New Years Day.
- c. **BLACK HAWK PROTECTION SERVICES INC.** shall invoice bi-weekly for the services rendered, which invoice shall be payable upon receipt. Payment not received by the 7th day after receipt of invoice shall accumulate interest on the unpaid balance at the rate of 1.5 % per month, but in no event to exceed the maximum lawful rate.
- d. In the event of any change in any law, regulation, ruling, or other such mandate, after the execution of this agreement, by any authority having restriction over the subject matter, which alters the hours of service, rates, numbers of days, working conditions, or cost of performing the service herein provided for, **CLIENT** agrees that this agreement shall be automatically subject to change to take into account such increased cost factors.
- e. Should a condition arise which calls for a substantial increase in the number of guards normally used to CLIENT, BLACK HAWK PROTECTION SERVICES INC. shall have a reasonable time in which to provide such guards, in such event, or in the event of a strike, walk-out, slow-down or other labor dispute or difficulty, whether approved by a labor agreement or not, CLIENT and BLACK HAWK PROTECTION SERVICES INC. agree to negotiate a charge in the rates charged CLIENT during the permanency of such conditions.

- f. In the event that BLACK HAWK PROTECTION SERVICES INC. becomes subject to any additional charges, taxes, fees, or cost through the providing of security guard services to CLIENT, or on account of the location, character, or other aspect of Client's location, in that event such additional charges, taxes, fees, or costs, shall be considered "pass through" expenses and CLIENT shall be liable for same in additional to all other rates and charges state herein, and shall be paid as invoiced by BLACK HAWK PROTECTION SERVICES INC. If such "pass through" expenses can be computed on the basis of hours of service performed, then the base rates, overtime rates, and holydays rates otherwise stated shall be adjusted accordingly.
- g. There shall be a yearly price increase until due to mandatory minimum wage increase as described on page 13 "What to expect for the following years"
- h. All non-paid returned check will be charge \$ 50.00 as administrative fee.

4.- LIABILITY AND CLAIMS:

- a. It is agreed and understood that BLACK HAWK PROTECTION SERVICES INC. is not an insurer of property or persons guarded. BLACK HAWK PROTECTION SERVICES INC. makes no warranty, express or implied, that the services it furnishes will avert or prevent occurrences, or the consequences there from, which may result in loss or damage.
- b. In no event shall BLACK HAWK PROTECTION SERVICES INC. be liable to CLIENT for any claim other than one which arises during the performance of services under this agreement and which is caused by the negligence of BLACK HAWK PROTECTION SERVICES INC., its employees or agents while acting within the scope of their duties and authority, in no event shall BLACK HAWK PROTECTION SERVICES INC. be liable for any claim caused in whole or in part by the acts of omissions of CLIENT or third parties or their respective employees or agents, or for consequential or incidental damages or loss of profits.
- c. In the event of any claim for which BLACK HAWK PROTECTION SERVICES INC. is liable, CLIENT agrees that BLACK HAWK PROTECTION SERVICES INC. liability shall be limited to a maximum amount, not to exceed the lesser of (i) the amount invoiced to and paid by CLIENT for services rendered within the 12 months period immediately preceding the date of the occurrence giving rise to the claim, or (ii) \$ 2.000.000 covered by the Company Liability Insurance Policy.
- d. The services provided under this Agreement are solely for the benefit of **CLIENT** and neither this Agreement nor any services rendered hereunder confer any rights on any other party as third-party beneficiary, or otherwise.
- e. CLIENT agrees to indemnify and hold BLACK HAWK PROTECTION SERVICES INC. harmless from and against any claims made by third party (s) including, but not limited to, injury, death or damages or loss of property, arising from BLACK HAWK PROTECTION SERVICES INC. negligent acts or omissions, including those related to the hiring, training, supervision or retention of personnel by BLACK HAWK PROTECTION SERVICES INC., its agents or employees.

- f. CLIENT shall give written notice to BLACK HAWK PROTECTION SERVICES INC., by registered or certified mail, return receipt requested, of a claim or potential claim arising out of or relating to this agreement or the services provided by BLACK HAWK PROTECTION SERVICES INC. within thirty (30) days following the date of the occurrence giving rise to such claim or potential claim. Such notice shall contain sufficient information as to the time, place, date, nature and extend of such claim or potential claim as will enable BLACK HAWK PROTECTION SERVICES INC. to be properly advised and make a reasonable assessment thereof.
- g. CLIENT shall provide reasonable cooperation to BLACK HAWK PROTECTION SERVICES INC. and to such insures(s) as BLACK HAWK PROTECTION SERVICES INC. may designate in order that claim or potential claim may be fully investigated and evaluated by such insurer(s) CLIENT acknowledges that any failure to provide such cooperation may result in the denial of its claim.
- h. No actions, suits or proceeding to recover any claim arising out of or relating to this agreement or the services provided by BLACK HAWK PROTECTION SERVICES INC. shall or may be brought against BLACK HAWK PROTECTION SERVICES INC. by CLIENT or by any person or party deriving rights or claiming through CLIENT unless (1) written notice of such claim was given to BLACK HAWK PROTECTION SERVICES INC. in the manner and form set forth in this paragraph 4; and (2) such action, suit or proceeding is instituted within three (03) months following the date or the occurrence giving rise to such claim.
- i. CLIENT agrees that in no event shall there be any right of offset or setoff, and that it shall not be entitled to retain any sums due to BLACK HAWK PROTECTION SERVICES INC. against any claims or potential claims against BLACK HAWK PROTECTION SERVICES INC.
- j. If CLIENT agrees security personnel to operate any vehicle during the course of their duties, other than personal vehicle belonging to security personnel or one supplied by BLACK HAWK PROTECTION SERVICES INC., CLIENT agrees to indemnify and defend BLACK HAWK PROTECTION SERVICES INC. against any claims, loses or other expenses that may arise from the use of said vehicle.

5.- HAZARDOUS OR DEFECTIVE CONDITIONS/MATERIALS:

a. CLIENT agrees to comply with all safety or health-related laws, or government requirements, including but not limited to, all OSHA requirements, including Hazard Communication Standards, and will indemnify and hold BLACK HAWK PROTECTION SERVICES INC. harmless from all claims and liabilities, including injuries to BLACK HAWK PROTECTION SERVICES INC. personnel, including employees or agents, arising out of any condition existing al CLIENTS'S premises, or CLIENT'S violations of any such laws or requirements.

6.- PROHIBITION OF EMPLOYMENT:

It is agreed between the parties that BLACK HAWK PROTECTION SERVICES INC. is not an employment agency and that BLACK HAWK PROTECTION SERVICES INC. has a substantial investment in its employees that are assigned to CLIENT'S premises and facilities. Therefore, in consideration of BLACK HAWK PROTECTION SERVICES INC. assigning security guard personnel to CLIENT'S facilities, CLIENT agrees that it shall not, either during the term, or any extension, of this Agreement, or for a period of two (02) years after its expiration or termination, employ directly or indirectly, any person who has been employed by BLACK HAWK PROTECTION SERVICES INC. CLIENT shall not cause, permit, nor suffer, any contractor (including but not limited to, other security firm or agencies) or affiliate, of CLIENT to violate this provision. In the event CLIENT shall violate, or cause, permit, or suffer, the violation of this restriction and prohibition, it is expressly agreed that liquidated damages in the amount of \$ 3,500.00 for each such employee shall be due and payable to BLACK HAWK PROTECTION SERVICES INC. on account of its investment in the recruiting, testing, training and supervision of such employees.

7.- NOTICES:

ί,

- a. All notices, request, demands and other communications required or contemplated herein shall be in writing and be deemed to have been when hand delivered to the party at the respective address of which the other party has been given notice in conformity with this provision.
- b. CLIENT shall give written notice to BLACK HAWK PROTECTION SERVICES INC. not less than thirty (30) days if any alleged "cause" to terminate this agreement exist and prior to the intended sale or disposition, in any manner, of the CLIENT, its business, or of the facility or property which is the subject of this agreement. In the event of any action or other litigation or proceeding which may have the effect of impacting adversely upon the CLIENT or its business including but not limited to, a foreclosure action, receivership or bankruptcy proceeding, CLIENT shall give notice to BLACK HAWK PROTECTION SERVICES INC. immediately upon the occurrence or upon CLIENT first becoming aware of such occurrence.

8.- ATTORNEYS FEES:

In the event it shall become necessary for BLACK HAWK PROTECTION SERVICES INC. to refer any amounts due from CLIENT to an attorney for collection, or to enforce any of the terms of this Agreements, CLIENT agrees to pay all cost of collection and/or enforcement, including reasonable attorneys fees and Court cost, for all levels and cost of litigation and appeal, and whether or not it becomes necessary to commence suit.

9.- BINDING EFFECT:

- a. This Agreement shall be binding upon and shall insure to benefit of the parties hereto and their respective representatives, successors, heirs and assigns.
- b. In the event of any sale or other disposition of the CLIENT or of the premises or property which is the subject of this Agreement, then in that event, the transferee shall be and shall remain responsible for any obligations or CLIENT outstanding as of the date of transfer, and for all terms and provisions of this agreement.

10. RECORDING:

At the option of BLACK HAWK PROTECTION SERVICES INC, this Agreement may be recorded in the county in which the real estate being protected is situated, and shall thereupon effect a lien upon the said real estate in favor of BLACK HAWK PROTECTION SERVICES INC. to the extent of any obligations owed under this agreement, whether then owed or subsequently accruing, including but not limited to, interest, late charges, reasonable attorneys fees, and costs of suit.

11. SEVERABILITY:

If any provision of this Agreement or the application of any provision to any person or circumstances shall be held invalid, illegal or unenforceable in any respect or for any reason, the invalidity, illegality, or unenforceability shall not affect any other provision and the remainder of this Agreement shall continue to be binding and in full force and effect, and shall be construed as if the invalid illegal or unenforceable provision had never been contained in it.

12. MATERIALITY:

All covenants, agreements, representations and warranties made herein shall be deemed to have been material and relied upon by each party to this Agreement.

13. ENTIRE AGREEMENT:

This written Agreement contains the sole and entire agreement between the parties, and all prior agreements, understandings and statements, oral or written, are merged into this Agreement.

14. MODIFICATION:

- a. No waiver or modification of this Agreement or any covenant, condition, or limitation herein contained shall be valid unless the parties mutually agree in writing.
- b. BLACK HAWK PROTECTION SERVICES INC. sales personnel are not authorized to sign, change, or amend this Agreement neither this Agreement, not any modification thereto, shall become binding upon BLACK HAWK PROTECTION SERVICES INC. until executed by an authorized corporate officer of BLACK HAWK PROTECTION SERVICES INC.

15. GOVERNING LAW:

This Agreement and the performance hereunder, and all suits and actions hereunder, shall be construed in accordance with the laws of the State of Florida. In any action that may be brought arising out of, in connection with, or by reason of this Agreement, the laws of the State of Florida shall be applicable and shall govern to the exclusion of the law of any other forum.

16. **VENUE**:

Any legal action arising out of, in connection with, or by reason of this Agreement, or instituted to enforce this Agreement, must be instituted in a court of competent jurisdiction sitting within the geographical boundaries of Dade County, Florida, to the jurisdiction of which the parties hereby consent.

17. FORCE MAJEURE:

Non-performance of any duty or undertaking under this Agreement shall be excused if caused or resulting from any Act of God, force of nature, war, insurrection, civil disturbance, terrorism, strikes, governmental orders, or any other event or instrumentality beyond the control of the party whose non-performance has occurred.

18. HEADINGS:

The headings contained in this agreement are for reference purposes only and shall not in any way affect the meaning or interpretation of this agreement.

19. SERVICE:

a. The Association service location shall be the complex located on 5691 NW 114 Avenue Doral, FL 33178

b. Insurance:

BLACK HAWK PROTECTION SERVICES INC. will maintain a \$ 2.000.000.00 Liability Insurance covering property and personal injury liabilities created by employees of BLACK HAWK PROTECTION SERVICES INC. while engaged in the performance of the work hereunder. The Association will be named as an additional insured in BLACK HAWK PROTECTION SERVICES INC. liability insurance policy; a copy of the Insurance Certificate shall be provided to CLIENT.

- c. BLACK HAWK PROTECTION SERVICES Security Officers are to be guided by BLACK HAWK PROTECTION SERVICES INC. rules and regulations as agreed upon by the association and BLACK HAWK PROTECTION SERVICES INC. and such other special written instructions applicable as may be issued by the Association. The Association may reasonably disapprove any personnel assigned by BLACK HAWK PROTECTION SERVICES INC. if such exercise is not in violation of any law, and BLACK HAWK PROTECTION SERVICES INC. agrees that upon request by the Association, BLACK HAWK PROTECTION SERVICES INC. shall substitute the individual within seventy two (72) hours of the Association request.
- d. BLACK HAWK PROTECTION SERVICES INC. Officers shall wear a uniform as determined by BLACK HAWK PROTECTION SERVICES INC. uniform policy. All uniforms must be fitted and dressed properly. The Association may reject an Officer or personnel that are improperly dressed and BLACK HAWK PROTECTION SERVICES INC. undertakes the responsibility to immediately replace and substitute any such Officer or personnel rejected by Association for failure to adhere to this uniform policy.
- e. BLACK HAWK PROTECTION SERVICES INC. and the Association agree to comply with all applicable Federal, State and local laws.
- f. All notices required or permitted under this Agreement shall be sent to the address set forth below, which address may be changed from time to time by written notice:

Each party reserves the right to insist upon strict performance of any provision in this Agreement, at any time, even if such performance has not been previously demanded.

- h. BLACK HAWK PROTECTION SERVICES INC. represents that it is licensed to render security guard services as provided for in this agreement and that is has complied with all the license requirements as mandated by the State and local governments. BLACK HAWK PROTECTION SERVICES INC. shall give all notices and comply with all laws, ordinances, rules, regulations and lawful orders of any public authority, bearing on the performance of the work.
- i. BLACK HAWK PROTECTION SERVICES INC. and its personnel shall observe and obey all rules and regulations of the Association. BLACK HAWK PROTECTION SERVICES INC. shall use reasonable care consistent with its rights to manage and control it operation not to permit any condition to achieve which shall or may cause or be conductive to any complaints, troubles, disputes or controversies which interfere with the operation of the Association facilities.
- j. In the event of an emergency, **BLACK HAWK PROTECTION SERVICES INC**. and/or its guard shall immediately contact the proper authorities and shall file a reports to the extent necessary.
- k. Written complex instructions, rules and regulations must be received from the Association in order to perform the duties as required and to enforce the rules.
